 - Sawcut/remove brick for new door opening.

 - Remove exiting and install new irrigation/sprinkler system adjacent to new concrete sidewalk area.

Renovation Work (furnish/install):

- o Prep and paint new door and frame, per Section 09 90 00.
- Prep subgrade for a new 5" thick concrete connecting sidewalk, including form/pour/finish/cure/strip, welded wire fabric (6x6—W2.0xW2.0), and 3,000 psi concrete.
- Maintain ADA slope/cross slope grades for new concrete sidewalk.
- Backfill and finish grade adjacent to the perimeter of new sidewalk with existing grades.
- Grout the new HM Frame to the brick masonry walls.
- Contractor to patch and repair all existing surfaces in the area of the demolition and replacement of the new door.
- Existing downspout to be connected to a new 4 inch ABS pipe underneath new concrete pad and daylight at edge of sidewalk.
