Furlough Days 2010-2011

Whereas the Center Joint Unified School District and the Center Unified Teachers Association have reached agreement on furlough days for School Year 2010-2011

Therefore, it is hereby understood and agreed by and between the parties as follows:

1. Certificated employees covered by the CUTA Collective Bargaining Agreement have agreed to donate two furlough days for the school year 2010 -2011.
2. The District has agreed to maintain Class Size Reduction at the 22:1 level for the school year 2010-2011.
3. The District has agreed to restore 8 multiple subject positions and 4 secondary positions for the school year 2010-2011.
4. The District and CUTA have agreed to revise the 2010-2011 school year calendar to incorporate the days to provide a week of vacation in February, 2011.

WHEREAS, the Governing Board of Trustees of the Center Joint Unified School District ("District"), by Resolution No. 13/2009-10, Resolution No. 18/2009-10, and Resolution No. 19/2009-10, determined to reduce or eliminate particular kinds of services of the District no later than the beginning of the 2010-2011 school year; and

WHEREAS, in accordance with that Resolution, the Superintendent or designee sent appropriate notices to all employees affected by said reduction of services; and
