- Graduation will be held Wednesday, May 29th in the Center High School Theater at 6:00 p.m. Over 25 students will walk the stage and receive their diplomas.

- Preschool graduation will be held May 28th in the Wilson C. Riles MultiPurpose Room

1. Career Technical Education (CTE) Pathways and Programs Update - Mike Jordan, Director of Curriculum/Instruction/Special Ed., reported on the following at Center High School: Arts, Media, and Entertainment Sector, Building and Construction Trades Sector – Geometry in Construction, Engineering and Architecture Sector – PLTW Engineering, Health Science and Medical Technology Sector – PLTW BioMedical Sciences, and the Public Services Sector – EMT Response. He then covered the Gateway Program at Wilson C. Riles Middle School and the Launch Program at Oak Hill Elementary. Mr. Loehr thanked Mr. Jordan for working tirelessly over the years to align these, and build these programs. He noted that the funding for CTE programs is getting very specific; we may need to pivot a little bit to make sure we can access the dollars to keep them going.

2. English Learner Program - Mike Jordan, Director of Curriculum/Instruction/Special Ed., reported that there are 520 EL students district-wide and 141 students were reclassified so far this year. He highlighted that the district transitioned from CELDT to the ELPAC test over the past year. The ELPAC tests will go online next year, and there is an EL teacher and bilingual aides at every school. He also noted that there were 37 students that qualified for the Seal of Biliteracy, 1 for Triliteracy, and 2 students were Quadrilingual.
