The Board is being asked to consider the proposed return to in-person reopening calendar for our school as present as back-up to this item.

The approval of these dates would allow us to transition to our in-person Plan 2 Hybrid model (which is a modified daily schedule) as outlined in our CJUSD Playbook. Any student not wishing to return to this in-person instructional model may remain in a 100% distance learning model for the remainder of the school year.
