- Governance A. **Organizational Meeting for Governing Board** Action  
 Because the Board Clerk position is vacant, the Board must elect a Clerk for the remainder of this calendar year.

**PUBLIC HEARING: Notification of Compliance With Education Code §60119 for Funds Received Under Pupil Textbook and Instructional Materials Incentive Program.**

- Curr & Instr B. **Certification of Provision of Standards-Aligned Instructional Materials** Action  
 This item would certify that as of this date, each pupil in the district in kindergarten through grade twelve, has been provided with a standards-aligned textbook or basic instructional materials to meet the requirements of Education Code Section 60422 (a).
- ↓ C. **Resolution #5/2020-21: Statement of Assurances Instructional Materials Fund** Action  
 This resolution is to certify that the district has sufficient materials in CORE subjects.
- ↓ D. **CHS Graduation Requirements - BP 6146.1** Action  
 The Department of Curriculum and Instruction is requesting the board approve changes to the graduation requirements, which include eliminating the computer applications (5 units) and CTE/Technology (5 units) requirements and adding those ten units to the number of electives requirements. The total number of units to graduate will remain at 260.
- ↓ E. **CHS Graduation Requirements for Special Education Students - AR 6146.4** Action  
 The graduation requirements for special education students listed in board policy AR 6146.4 do not meet the minimum requirements as set forth by the California Department of Education. Therefore, the Department of Curriculum, Instruction and Special Education is requesting the board approve a change in AR 6146.4 to replace the section under the heading of Graduation and Curriculum Standards.

**PUBLIC HEARING: Learning Continuity and Attendance Plan**

Education Code (EC) Section 43509 requires that the governing board hold a public hearing on the Learning Continuity and Attendance Plan at a public meeting. The purpose of this hearing is to set aside time to provide information to the public and to receive public comment and input on the district's Learning Continuity Plan for the 2020-2021 school year.

↓ F. **2020-2021 Learning Continuity and Attendance Plan** Discussion  
The purpose of the Learning Continuity and Attendance Plan is to balance the needs of all stakeholders including educators, parents, students and community members to memorialize the planning process that is already underway for the 2020-21 school year. This replaces the Local Control Accountability Plan for the 2020-21 school year and supersedes the requirements in Executive Order N-56-20.

Business G. **2019-2020 Unaudited Actuals Report** Action  
The Unaudited Actuals Report covers all fiscal activity and fund balances for the District.

↓ H. **Resolution #8/2020-21: Gann Limit Resolution** Action  
School districts are required to certify via the Gann Limit that their annual revenues do not increase at a rate greater than the overall increase in state government revenues. CJUSD has met that requirement for the 2019/20 fiscal year.
