Governance В. Schedule Annual Organizational Meeting of the Board Action

Education Code §35143 requires governing boards to set an annual organizational meeting "within a 15-day period that commences with the date upon which a governing board member elected at that election takes office. Organizational meetings in years in which no such regular election for governing board members is conducted shall be held during the same 15-day period on the calendar." (Board members are seated the first Friday of December following the November election [Education Code §5017]) That 15-day period for 2021 is December 10-24.

C. **CSBA Delegate Assembly Nominations** 

> Nominations will be accepted until Sunday, January 7, 2022. Any CSBA member board is eligible to nominate board members within their geographical region or subregion. Each board may nominate as many individuals as it chooses. The subregion for CJUSD is 6-B.

D. Authorization for the CJUSD Financing Team to Proceed with the Action Sale, in an Aggregate Principal Amount Not to Exceed \$43,000,000, of the Issuance and Election of 2008, Series 2021B General Obligation **Bonds** 

> This is a follow-up to Resolution #7/2021-22 that was passed by the Board of Trustees at the October 20, 2021 Board Meeting. Approval of this would allow the CJUSD Financial Team to determine the amount of bonds to be sold (not to exceed \$43,000,000) and proceed with the process.

 $\downarrow$ E. **BB 9220 – Governing Board Elections**  Action
