C. Resolution #7/2022-23: RESOLUTION OF THE BOARD OF TRUSTEES OF CENTER JOINT UNIFIED SCHOOL DISTRICT AUTHORIZING THE ISSUANCE AND SALE OF ITS GENERAL OBLIGATION BONDS, ELECTION OF 2008, SERIES 2022C, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$14,000,000, AND APPROVING CERTAIN OTHER MATTERS RELATING TO SAID BONDS

The resolution before the Board authorizes the District to issue its General Obligation Bonds, Election of 2008, Series 2022C (the "Bonds") to finance the construction, acquisition, improvement, furnishing and equipping of District facilities and pay the costs of issuing the Bonds. The resolution also approves the sale of the Bonds on a negotiated basis and other documentation prepared in connection with the issuance of the Bonds, namely the Continuing Disclosure Undertaking, the Preliminary Official Statement, and the Bond Purchase Agreement.
