Curr & Instr G. **Instructional Materials Adoption Grades TK-5, FOSS Next Generation Science Curriculum** Action
 The Curriculum and Instruction Department recommends adopting the FOSS Next Generation Science Curriculum for grades TK-5. After the initial elementary science adoption process was derailed due to the COVID pandemic (see the attached document for detailed information), the FOSS science curriculum was piloted by 43 TK-5th grade Elementary Summer School teachers along with 400 students at all 4 elementary schools (Dudley, Spinelli, North Country, and Oak Hill) during the summer of 2022. Teacher’s feedback was very positive. With the adoption of these materials, we will have completed our adoption cycle for Next Generation Science Standards materials for the grade band TK-5th grades.

↓ H. **English Learner Newcomer Curriculum Adoption – Middle and High School** Action
 The Curriculum and Instruction Department recommends that the CJUSD school board approve the adoption of *Inside the USA Essential Language and Literacy Skills for Newcomers by National Geographic/Cengage.* This supplemental ELD curriculum is part of the currently adopted and used ELD curriculum at the middle and high school levels. It will be used with Newcomers, which are defined as an ELD student who was born in a country other than the United States and has enrolled in US schools for the first time within the last 3 years.
