What is the District and WCR staff going to do to help this transition be as smooth as possible?	Keeping students with their current teachers is a priority for us as a district. What is the District going to do if there is a major outbreak? Will all students go back to Distance Learning?	The district will work in conjunction with the Sacramento County Department of Health to determine the appropriate course of action based on the current conditions in the county.
Is November and flu season the best time to do this? When the rest of the Sacramento school districts have decided to start later in the year, why do we need to reopen months before? What's the rush?	The decision was made to begin in- person instruction on January 5, 2020. The district will continue to monitor the situation and work with the Sacramento County Department of Health.
Does a student who signed up for hybrid in-person learning, have the option to distant learn until after the winter break?	All students will continue in distance learning until January 5, 2021.
What are other Sac County schools doing about reopening their schools?	Only three other districts have decided on dates to reopen. Twin Rivers and San Juan school districts have chosen January dates and the Folsom- Cordova district has decided on a November date.
If the MOU is not signed or if the teacher's union does not agree to the Nov 9th start date what are the alternatives? OR is there another plan for instruction?	The decision was made to begin in- person instruction on January 5, 2020. MOU negotations are continuing as scheduled.
will the teachers change in the cohart program	More cohorts/Learning Hubs are in the planning stages to begin in the coming weeks. We will also prioritze keeping all students with their teachers but some may have to change.

What will happen to classified employees if we return at a later date in Jan ?Like Transportation will we continue to work on site before Jan?	Transportation Dept. will continue in the same status as they are today.
How are students being assigned to blue and gold groups?	Intiially we are dividing the students by alpha but other adjustments may need to be made to account for families or other circumstances.
Why has McClellan not been addressed in the presentation?	McClellan High School is small enough that students are able to return to their normal schedule. Those students who choose full-time distance learning will be participate live, online through sychronous learning.
